



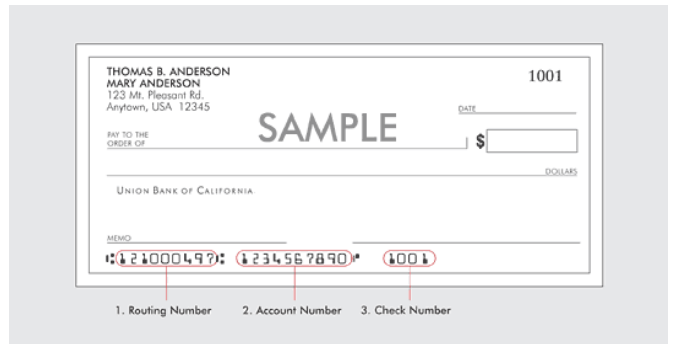

By law, you are entitled to terminate this Agreement via written notice of resignation received by Genesis Fitness within three (3) days of making this agreement after which a full refund of fees and dues will be paid within thirty (30) days of receipt of resignation. Genesis Fitness reserves the right to cancel your membership at any time without notice. If we do cancel your membership you will receive a refund of prorated charges to the date of cancellation. _____ (initial)
